St. Luke's 2-Year Strategic Plan: Revitalizing our Parish Post-Covid

MISSION: The people of St. Luke's Parish strive to love and serve God and humanity through prayer and action, nourished by the sacraments and the Word of God.

- Produce an engaging community experience for those who attend Sunday mass.
- Strengthen existing ministries (Eucharistic, Readers, Music, Altar Servers, Children's Liturgy, Sacrament Preparation, and Greeters) and ensure those involved feel valued, appreciated, and well-informed of responsibilities.

OBJECTIVE 3 – To establish the parish as a focal point of Christian discipleship and provide opportunities for continued spiritual growth. (Outreach)

- Create opportunities for parishioners to foster spirituality and discipleship growth through championing justice and fairness.
- Serve those in need, in both our community and more broadly.


OBJECTIVE 4 – To create a parish community that is vibrant, social, welcoming, and active to encourage parishioner involvement. (Community Life)



SUMMARY

MOVING IN THE RIGHT DIRECTION

2022 provided a brighter financial outlook than the past four years, with a surplus of \$17,998 revenue over expenses. This reflects an increase in offertory donations, with a weekly average contribution of approximately \$2,300 (\$1,913 cash; \$387 pre-authorized payment). Expenditures have been reduced to the absolute bare minimum in order to get through COVID & post-COVID, so this modest surplus reflects an extremely lean operating model.

Looking Ahead



Orientation & Planning - The new Finance Committee will be meeting over the summer months to learn more about the Parish's finance management, upcoming capital expenses and to develop a short- and long- term finance plan for the parishioner's considerations. A Parish finance planning meeting will be held with Parish group leaders on Wed. September 20 at 7 pm.

Capital Expenses - The Finance Committee will be gathering quotes for capital expenses, including major and minor building repairs over the summer months.

Parish Coordination - The Finance Committee is seeking applicants for a Parish coordinator role, comprised of communication, administration, and bookkeeping activities. The newly defined role will replace the current secretary role and will include supporting the Parish Communications Team, and updating/ modernizing finance management. The Finance Committee will support the successful candidate to develop efficient processes and procedures. The Job posting will close on Monday June 12, 2023.
